Egypt: Inter-African Committee on Traditional Practices (IAC) holds General Assembly/International Conference in Cairo

## Norway: Action Plan for combating Female Genital Mutilation

FGM is prohibited and punishable by law in Norway. The practice conflicts with fundamentals of human rights and with the UN convention on the Rights of women and girls. As a result, the government of Norway launched a new four-year Action Plan for Combating Female Genital Mutilation. The Plan constitutes a broad initiative against genital mutilation aimed at both prevention and securing accessible health care for women and girls who have been exposed to genital mutilation.

Several groups and NGO's are calling upon the government to embark on a national Action Plan to fight FGM. The appeal has been brought to the attention of the Minister of Health and Social Services, so that it may be adopted to the legislation.

# Egypt: Egypt's First Lady Targets Female Genital Mutilation

Egypt's first lady, H.E. Mrs. Suzanne Mubarak, and Chief of the technical committee of Egypt's National Council for Childhood and Motherhood, inaugurates the seventh international conference of the African committee for fighting harmful practices on 27 October 2008. The conference, themed as "Partnership with mass media to fight harmful practices," received various participants from UN agencies and African NGO's . FGM was discussed as being a" harmful practice that poses a threat to achieving the Millennium Development Goals," according to an Egyptian government official.

## Uganda : Female Genital Mutilation banned in Uganda

### Liberia: FGM Continues in Rural Secrecy

In Liberia, Sierra Leone, and Guinea, thousands of young girls are sworn to secrecy as part of their initiation into the secret association of the Sande Society. These young girls promise not to tell uninitiated girls and men about what they experience in their weeks of training in the forest, assume new names and have their clitoris cut off. Although, 20 percent of initiated girls die due to complications resulting from the FGM procedure, cultural conceptions are very difficult to change.
