

AN INTERNATIONAL CALL FOR ACTION TO END VIOLENCE AGAINST CHILDREN:

Establish a Special Representative to the UN Secretary-General on Violence against Children

Violence is a daily reality for millions of children around the world, affecting girls and boys of all ages, all social contexts, and all nationalities. In every part of their lives — their homes and families, schools, institutions, workplaces and communities — children may be beaten, sexually assaulted, tortured, and even killed. The perpetrators of this violence are often the very individuals who are responsible for protecting children — their parents, guardians, teachers, employers, the police and security forces. Violence is a global epidemic of scandalous proportions, violating every child's right to a safe and healthy environment.

The UN Secretary-General's 2006 Study on Violence against Children exposes the shocking scope of violence against children and documents its devastating effects on children, their families, their communities, and broader society. The Study clearly establishes the urgent need for immediate action to prevent and respond to violence against children in all of its forms.

We, as local, national, regional, and international non-governmental organizations from every part of the world, call on each UN member state to fully implement the Study's important recommendations.

Having carefully considered alternative ways of ensuring global leadership on this issue, we also call on member states to act at the 2007 UN General Assembly to establish a Special Representative to the Secretary-General on Violence against Children to work with the UN system, member states, NGOs, children and youth as a high-level and high-profile advocate to ensure concrete action to end violence against children in all parts of the world.

UN APPEL INTERNATIONAL POUR EN FINIR AVEC LA VIOLENCE CONTRE LES ENFANTS:

Etablir un Représentant spécial du Secrétaire Général de l'ONU sur la violence contre les enfants

Tous les jours, des millions d'enfants dans le monde sont victimes de violence : des filles et des garçons de tous âges, de tous les milieux sociaux et de toutes les nationalités. Partout où ils vivent – au sein de leurs foyers et de leurs familles, à l'école, dans les institutions, sur les lieux de travail et dans leurs communautés – les enfants peuvent être battus, agressés sexuellement, torturés et même tués. Les auteurs de cette violence sont souvent les personnes qui sont aussi responsables de la protection des enfants – les parents, les gardiens, les professeurs, les employeurs, la police et les forces de sécurité. La violence est un fléau mondial qui s'étend de manière scandaleuse, violant le droit de tout enfant de vivre en sécurité et dans un milieu sain.

L'étude de 2006 du Secrétaire Général de l'ONU sur la Violence contre les enfants montre l'étendue impressionnante de cette violence ainsi que ses effets destructeurs sur les enfants, leurs familles, leurs communautés et la société en général. L'étude constate clairement le besoin urgent d'une action immédiate pour prévenir et lutter contre la violence faite aux enfants sous toutes ses formes.

En tant qu'organisations non gouvernementales locales, nationales, régionales et internationales de toutes les régions du monde, nous appelons tous les Etats membres de l'ONU à mettre en œuvre les importantes recommandations de cette étude.

Ayant attentivement considéré les différents moyens de garantir une autorité mondiale dans ce domaine, nous appelons les Etats membres à agir, lors de l'Assemblée Générale de 2007, en vue de nommer un Représentant spécial du Secrétaire Général de l'ONU sur la Violence contre les enfants. Il travaillera avec le système onusien, les Etats membres, les ONG, les enfants et les jeunes en tant que défenseur de haut niveau et de renom qui entreprendra des actions concrètes afin d'en finir avec la violence contre les enfants partout dans le monde.

**UN LLAMADO INTERNACIONAL
PARA PONER FIN A LA VIOLENCIA CONTRA LOS NIÑOS, NIÑAS
y ADOLESCENTES**

**Por la designación de un/a Representante Especial
en Violencia contra los Niños, Niñas y Adolescentes**

La violencia es una realidad diaria para millones de niños, niñas y adolescentes alrededor del mundo, afectando a personas menores de edad de ambos sexos y edades, de todos los contextos sociales, y de todas las nacionalidades. En cada parte de sus vidas - sus hogares y familias, las escuelas, las instituciones, los lugares de trabajo y las comunidades - los niños, niñas y adolescentes pueden ser maltratados, abusados sexualmente, torturados, así como asesinados. Los ofensores de esta violencia son a menudo las mismas personas que son responsables de protegerlos - sus padres, madres, cuidadores/as, profesores/as patrones/as, la policía y fuerzas de la seguridad. La violencia es una epidemia global de proporciones escandalosas, violentando el derecho que tiene cada niño, niña y adolescente a vivir en un ambiente seguro y sano.

El estudio del Secretario General 2006 de la O.N.U sobre violencia contra los niños y las niñas expone el alcance impactante de la violencia hacia esta población y documenta sus efectos devastadores sobre los niños, niñas y adolescentes, sus familias, sus comunidades, y ante una sociedad más amplia. El estudio establece claramente la necesidad urgente de la acción inmediata de prevenir y de responder a la violencia contra niños, niñas y adolescentes en todas sus formas.

Como organizaciones locales, nacionales, y regionales, y organizaciones no gubernamentales internacionales de cada parte del mundo, invitamos a cada Estado Miembro de la O.N.U a poner en práctica todas las importantes recomendaciones del estudio.

Habiendo cuidadosamente revisado las diferentes maneras y alternativas para asegurar un liderazgo global en este tema, invitamos a los Estados Miembros a actuar en la Asamblea General de la ONU en el 2007, solicitando la designación de un/a Representante Especial del Secretario General en violencia contra los niños y las niñas. Dicho/a Representante Especial trabajará con el Sistema de la ONU, sus Estados Miembros, las ONGs, los niños, niñas y adolescentes, fungiendo como defensor/a con un alto nivel y un fuerte perfil para asegurar la acción concreta de poner fin a la violencia contra niños, niñas y adolescentes en todas las partes del mundo.

دعوة للتحرك الدولي لإنهاء العنف ضد الطفل تخصيص ممثل خاص للأمين العام للأمم المتحدة بشأن العنف ضد الطفل

العنف واقع يومي لملايين الأطفال في جميع أنحاء العالم، يتأثر به الفتيات والفتيان من كافة الأعمار وكافة السياقات الاجتماعية والجنسية. ففي كل جزء من حياتهم- في المنزل والأسرة والمدرسة ومؤسسات الرعاية وأماكن العمل والمجتمعات المحلية- قد يتعرض الأطفال للضرب، والاعتداء الجنسي والتعذيب وحتى القتل.. وغالبا ما يكون مرتكبو هذا العنف ضد الأطفال هم أنفسهم الأفراد المنوط بهم حماية هؤلاء الأطفال- الآباء، والأوصياء، والمعلمين، وأصحاب العمل، وقوات الأمن والشرطة. وبعد العنف بمثابة وباء عالمي متفشي ينتهك حق كل طفل في بيئة آمنة وصحية.

تسلط دراسة الأمين العام للأمم المتحدة الصادرة عام 2006 حول العنف ضد الطفل الضوء على النطاق الفظيع الذي يطاله العنف ضد الأطفال، هذا وقد قامت الدراسة بتوثيق آثار العنف المدمرة على الأطفال، وأسره، ومجتمعاتهم، والمجتمع عامة. كما تشير الدراسة بوضوح للحاجة العاجلة لتحرك فوري بغرض منع كافة أشكال العنف ضد الطفل، كما والاستجابة لها.

ونحن- كمنظمات غير حكومية محلية ووطنية وإقليمية ودولية من جميع أنحاء العالم- نطالب كافة الدول الأعضاء بالأمم المتحدة بتنفيذ التوصيات المهمة للدراسة تنفيذاً كاملاً وتاماً.

وفي هذا السياق، وإذ أخذنا في حسابنا الدقبة السبل البديلة لضمان قيادة عالمية لهذه القضية، نناشد أيضا الدول الأعضاء في الجمعية العامة للأمم المتحدة لعام 2007 للعمل على تخصيص ممثل خاص للأمين العام بقضية العنف ضد الطفل. وذلك للعمل بالتضافر مع نظام الأمم المتحدة، والدول الأعضاء، والمنظمات غير الحكومية، والأطفال والشباب كمناصر على مستوى عالٍ وملحوظ من أجل ضمان تحرك ملموس في قضية إنهاء العنف ضد الأطفال في جميع أنحاء العالم.

МЕЖДУНАРОДНЫЙ ПРИЗЫВ К ДЕЙСТВИЯМ ПО ПРЕКРАЩЕНИЮ НАСИЛИЯ ПРОТИВ ДЕТЕЙ

Назначение специального представителя Генерального Секретаря ООН по вопросам прекращения насилия против детей

Насилие – это ежедневная реальность, с которой сталкиваются миллионы детей во всем мире. Мальчики и девочки всех возрастов, социальных слоёв и национальностей. В любой момент повседневной жизни – дома, в семье, школе, учреждениях, на рабочих местах или же просто в обществе – дети могут подвергнуться избиениям, половому насилию, пыткам и даже смерти. Лицами, прибегающими к насилию, чаще всего являются люди, несущие ответственность за безопасность детей – их родители, опекуны, учителя, чиновники, полицейские и службы безопасности. Насилие – это мировая эпидемия чрезвычайных размеров с нарушением прав детей на безопасное и здоровое окружение.

Исследование последствий Насилия против Детей, проведенное Генеральным Секретарем ООН в 2006 году, демонстрирует шокирующий масштаб насилия и его разрушающее действие, как на детей, так и на их семьи, общины и общество в целом. Исследование наглядно показывает срочную необходимость принятия мер по предотвращению и прекращению насилия против детей во всех его формах.

Мы - национальные, региональные и международные неправительственные организации со всех уголков мира - призываем все страны-члены ООН максимально полно выполнить рекомендации, данные в этом исследовании.

Тщательно рассмотрев все возможные варианты решения этой проблемы на мировом уровне, мы призываем страны-члены ООН принять необходимые меры для назначения на Генеральной Ассамблее ООН в 2007 году Специального представителя Генерального Секретаря по вопросам прекращения насилия против детей.
