DRAFT ANNOTATED AGENDA¹

Context

This theme lies within the **following international context**:

- The "Special Session of the United Nations General Assembly on Children" (New York, POSTPONED) called for by the General Assembly (Resolution 55/26 of 20 November 2000). This special session will provide the opportunity to take stock of the implementation of the World Declaration in favour of the survival, the protection and development of the child and of the Action Plan for the application of the Declaration (adopted in 1990), and to make new commitments. The Committee of Ministers of the Council of Europe adopted on 9 May 2001 a political message for communication to the Special Session of the United Nations General Assembly on Children.
- The **World Day on Children** (20 November);
- The **World Youth Festival** (Panama, July 2001), launched in the 60s, is an event that aims to promote cultural, social and educational exchanges taking into account the characteristics and human conditions of this new century.
- The 4th session of the **United Nations World Youth Forum** (Dakar, August 2001) following Resolution 54/120 I of the General Assembly of 17 December 1999. The Forum will examine the progress made with regard to the application of the Youth Action Plan as defined in Braga in 1998, and will formulate recommendations, strategies and tools allowing young people to take part in the decision-making process and in the evaluation of policies and programmes that concern them.

This theme will also take into consideration the following North South Centre activities:

• **Global Education Week**, which in 2001 will address "Children and Youth Rights Now: For our Common Future" (November 2001).

• The award of the **2000 North South Prize** to Marguerite Barankitse, in charge of reception centres for orphan children in Burundi.

The results of the international conferences mentioned above will be taken into consideration during the discussions, notably with regard to new commitments made and contributions by the Lisbon Forum participants with regard to the implementation of these commitments.
