# "A World Fit for Children" The Views of Children and Young people.

Report from a meeting of children from the 6<sup>th</sup> region of Chile Rancagua, Chile 5/5/01

The consultation with children about their opinions of the document "A World Fit for Children" in Chile took place in Rancagua in the VI region. It was organised by ACHNU (Asociación Chilena Pro Naciones Unidas), an NGO working for the promotion of the rights of the child. The participants were members of organisations associated with GAMA, an environmental project for young people, and their friends.

The methodology suggested by Save the Children was used, but due to lack of time not all questions were discussed. After an initial introduction to the Special Session and the importance of the opinions of children and young people the participants were divided into three groups and asked to discuss the document considering the questions provided by Save the Children. The questions were divided as follows:

- Group 1: Declaration and Plan of Action.
- Group 2: Declaration and Goals, Strategies and Actions Health and Education
- Group 3 Declaration and Goals, Strategies and Actions Abuse and HIV/AIDS

# Summary of the discussions

#### Declaration

What are the three most important things which need to be done to make these 10 principles work for children?

1. Provision of more resources for health and education.

With regards to education the importance of civic education was emphasised, i.e. the importance of educating children as well as adults about their civil and human rights. An important part of implementing the principles in the declaration is that people are aware of the promises of their governments.

In the area of health it was suggested that a more professional health service was necessary with better equipment and better methods of diagnosing illnesses.

It was also pointed out that the Chilean government does not lack resources but chooses to spend existing resources for military purposes such as the purchase of fighter jets, rather than on social services. 2. Better support and resources for institutions and organisations working with and for children.

The importance that institutions working for children listen to children in order to gain a better understanding of what they need and want was discussed.

The government should support the formation of organisations working with and for children and adolescents.

- 3. Support for families in order to provide an abuse free environment for children to grow up in.
- 4. Children must be included in the work to implement the principles of the declaration, platforms from which children can express their opinions should be provided. All institutions dealing with children and young people of the community should discuss matters with the children and take into consideration their opinions.

## Plan of Action

## 1. Creating a child-friendly world.

Do you think that these are the most important issues for government to address in order to build a better world for and with children?

Yes, we agree that these issues are important but believe that the importance of technology is missing from the list. Today technology is fundamental both in order to adapt to modern times as well as in order to incorporate children into the modern world. For example, children living in rural areas and lacking access to communications technology become isolated both from urban areas as well as from development and modernisation.

#### 2. Goals, strategies and actions

The following 4 areas have been given a high priority for action over the next 10 years: Health, Education, Abuse, Violence and Exploitation and HI V/SI DA Are their any other issues that need to be included?

Yes, the following:

- Recreation, amusement and play.
- The protection of the environment
- Prevention of social discrimination
- Support for the family

What do you think are the biggest problems facing children in these 4 areas? And what do you think needs to be done about them?

## I. HEALTH

Problem: Solution:	Difficulty getting access to health care. Free heath care for children, both physical and psychological.
Problem:	Inadequate context - health care institutions are not suitable for children.
Solution:	To provide a better environment in these institutions.
Problem:	Segregated attention
Solution:	The service should be integral and multidisciplinary
Problem: Solution:	School health services are bad They should be more professional.

# II. EDUCATION

Problem:	The educational reform
Solution:	To implement it properly
Problem:	Infrastructure
Solution:	More and better schools
Problem: Solution:	They don't take into consideration the family The family should be included in the education of their children and made to participate. Education shouldn't be seen as something that only takes place in schools.

# III. ABUSE

Problem:	Agricultural Labour	
Solutions:	Better control/inspection of agricultural labour	
	Public manifestations and protests	
	Spread information about the issues	

Problem: Abuse within the family

Solutions: Make sure abuse gets reported

Create consciousness about the issues through campaigns, education and meetings with parents and children.

#### IV. HIV/AIDS

HIV/SIDA is still taboo in Chile, as sex isn't something that is talked about. The theme isn't dealt with. A first step in solving this problem is to star talking about the matter.
